#### **COURSE DESCRIPTION**

This course takes a close look at sustainable investing, with a special focus on alternative asset classes like venture capital, private equity, real estate and infrastructure. It will also cover diverse aspects of sustainable finance theories, including ESG Financing, financial inclusion, socially responsible investing and impact investing issues.

#### **LEARNING OBJECTIVES**

At the end of the course, participants will be able to:

- Describe how sustainable investing is defined and implemented by companies and investors across regions and asset classes, including key frameworks and strategies
- Apply cutting edge theory on sustainable finance issues like green and climate financing, innovative NGO strategies and impact investments to real-world investment decisions.
- Identify and describe traditional and "new" alternative investments, including size, growth, performance and profitability of asset classes, as well as common investment strategies
- Assess the suitability of sustainable investing and alternative investments to different classes of investors, and how products fit within an institutional investment and managerial frameworks
- Make informed decisions about allocation to sustainable investment strategies and alternative investments, including alternative investments with a sustainability tilt

#### **INSTRUCTIONAL METHODS AND EXPECTATIONS**

Class sessions are of 3-hour lectures for three times per week. Lectures will include content discussions.

**Group Project/Case Studies**: For the group project/case studies, there will be 6 teams. **Quiz**: There will be one in-class quiz. The time limit for the quiz will be 30 minutes. I do not give make-up quizzes. However, if you are officially excused because of a serious illness or family crisis or other reasons, you must contact me by email at least one week prior to the quiz for alternative arrangements.

**Final Essay Assignment**: There is a final essay assignment with two essay questions. Questions will be posted on ELEARN one week before its due date. Students are required to upload their typed essay on to the ELEARN on time. Late submissions may be subjected to a penalty deduction.
