## APPLICATION REQUIREMENTS

GWP welcomes university students from around the world.

Students are to include the following in their GWP applications:

- ❖ Latest academic transcript or official acceptance letter from home university
- ❖ Photo identification page of a passport (valid for at least 6 months from programme start date)
- ❖ Recent passport-sized photograph (taken within 3 months before the date of application)
- ❖ Latest English language proficiency certificate\*

### English Language Prerequisite

English is the language of instruction at SMU. If English is not the main language of instruction of a student's university, he/she should submit either his/her IELTS or TOEFL test results. We admit students who score at least:

Paper-based TOEFL	577
Internet-based TOEFL	90
International English Language Testing Systems (IELTS)	6.5

\* The test must be taken within 2 years at the time of application.

## APPLICATION ELIGIBILITY

Students may apply to GWP as a:

- ❖ Fee-paying student from a non-partner university
- ❖ Fee-paying student from a partner university
- ❖ Fee-waived student from a partner university (nominated by home university)\*

Students are to consult their home university administrators on their study plan and the approval for transfer of course credits **before** applying to GWP.

\*Nominated students would receive email instructions from the SMU Centre for Global Education and Opportunities to submit their GWP application.

## ACADEMIC INFORMATION

**Course Load:** Students may choose to take any 1 course during GWP.

**Class Format & Size:** 3 interactive seminar-style classes per course per week over 3 weeks. Each class is made up of between 20 and 45 students.

**Credit Weightage:** Each course confers 1.0 SMU credit and consists of 36 contact hours.

**Course Assessment:** Assessment can include, but is not limited to (i) class attendance; (ii) class participation; (iii) project (individual/group); (iv) presentation (individual/group); (v) class tests/quizzes

**Class Attendance:** Attendance will be a component of the course assessment, and students are required to attend all classes. Absence due to health or medical reasons must be supported by a medical certificate. For absences due to other reasons, prior approval must be obtained from the course instructor in writing.

Students who fail to attend classes continuously for a period of 7 days will be automatically withdrawn from the programme, and their Student's Pass will be cancelled, effective from the 8<sup>th</sup> day.

## COURSE ENROLMENT

Before applying to GWP and submitting course preference(s), students should:

1. Understand the details of their preferred course(s) by reading the course outline(s).
2. Consult their home university administrators on the transfer of course credits for the GWP courses of interest.

Students would be informed of their allocated course(s) via an email offer of placement.

## DIGITAL TRANSCRIPT

Students will receive their digital transcripts and one certificate of participation two months after the release of their final course grades.

## PROGRAMME FEES – FEE-PAYING STUDENTS

### Fee-Paying Students (From Non-Partner Universities)

6 or more students from the same university who are successfully enrolled in GWP are eligible for a 10% discount on their tuition fees.

Each student must make an application fee payment of SGD150 within **3 days** of application submission and payment of SGD1,000 deposit and SGD230 miscellaneous fee within **7 days** from SMU's conditional offer email.

### Fee-Paying Students (From Partner Universities)

Students from SMU partner universities are eligible for a 10% discount on their tuition fees. With 6 or more students from the same partner university successfully enrolled in GWP, this discount increases to 15%.

Each student must make an application fee payment of SGD 150 within **3 days** of application submission and payment of SGD 1,000 deposit and SGD 230 miscellaneous fee within **7 days** from SMU's conditional offer email.

## PROGRAMME FEES – NOMINATED EXCHANGE STUDENTS

### Nominated Exchange Students

Students who are nominated by their home university as an exchange student on a fee-waiver basis are not required to pay tuition fees to SMU.

Students are however still required to pay SMU for the SGD150 application fee within **3 days** of application submission and SGD230 miscellaneous fees within **7 days** from SMU's conditional offer email.

## MISCELLANEOUS FEES

[All students are required to pay miscellaneous fee of SGD230 that covers the cost of student \*\*medical insurance\*\* \(including COVID-19 coverage but within Singapore only\), IT services and matriculation fees.](#)

This fee is compulsory and non-refundable.

**It is highly encouraged for all international students to purchase their personal travel insurance (which is not covered under this miscellaneous fee).**

## INTERNATIONAL SOS (ISOS)

## STUDENT'S PASS (VISA)

It is mandatory for all international students enrolled in our programme to have a valid Student's Pass during their study in Singapore. Please note that students are not permitted to undertake any form of internship (paid or unpaid) during their term of study in Singapore.

The SMU Centre for Global Education and Opportunities **only facilitates** the registration of student's particulars with Singapore Immigration Checkpoints Authority (ICA). Students are responsible for the application of the Student's Pass thereafter on the ICA SOLAR portal.

### 1. Registration for a Student's Pass

SMU will register you through SOLAR with the following information:

- Your name, date of birth, gender and nationality (as appear in your travel document)
- Course details, course commencement and course end dates
- SOLAR application reference number

### 2. Submission of eForm16

Once SMU has successfully registered your information, you may login to SOLAR to submit eForm16. You must have the following information before logging into SOLAR:

- SOLAR application reference number provided by SMU
- Passport details (including travel document/passport number, date of expiry, etc)
- A Singapore address and contact details
- Your email address
- One recent passport-sized colour photograph (to be attached to e-Form 16) and must meet the following requirements:
  - Image must be taken within the last 3 months
  - Photograph should be in colour, must be taken against a white background with a matt or semi-matt finish
  - Image must show the full face and without headgear (headgear worn in accordance with religious or racial customs is acceptable but must not hide the facial features)

### 3. Approval of Student's Pass

Upon submission of the eForm16 and payment of visa application fee through SOLAR, students are required to print a copy of the eForm16.

If the application is successful, students are required to pay for the issuance of student's pass and book an appointment on ICA website to complete student's pass formalities in Singapore before the start of the programme on 5 January 2026.

The total fees for the Student's Pass application and issuance range from SGD105 to SGD135. Fees are determined by and payable to ICA and are non-refundable. For extension of stay beyond the Student's Pass validity, a valid visa may be required, and students are to check with ICA directly.

More information on Student's Pass application will be provided in via SMU's email.

## ACCOMMODATION

On-campus accommodation is not available for GWP students. However, there are many housing options (e.g., hostel, co-living space) located within walking distance to the campus and the university is accessible by Singapore's public transportation network (e.g., trains, buses, etc.)

While students are responsible for sourcing and arranging for their own accommodation, SMU has made some arrangements with off-campus accommodation providers to cater to students' needs. However, rooms are limited and are subject to availability and students are to reach out to the providers directly. For more information, please see below.

### Note:

SMU does not serve in any capacity or representation, to endorse nor recommend any of the accommodation options.

GWP students **should not** be renting rooms or houses from private residential properties. According to the [Singapore Urban Redevelopment Authority \(URA\)](#), private residential properties may not be used for short-term rentals and must be rented out for at least 3 consecutive months.

Students are required to confirm the costs and associated fees, make their own reservations directly with any of the operators if they are interested. Any lease or tenancy agreement entered into, shall be between the tenant (student) and proprietor / service provider. SMU does not seek to represent either party on matters arising from any disputes or legal issues. Students are required to read and understand all Terms and Conditions and legal rights before committing to any agreements / contracts in the form of signature and / or payment.

## LIVING EXPENSES

The estimated living expenses for an international student in Singapore is approximately SGD2,510 – SGD3,900 per month. Some common monthly expenses include:

<b>Accommodation (Depending on hostel and room type):</b>	SGD1,800 – SGD2,400
<b>Food:</b>	SGD450 – SGD900
<b>Local Public Transportation:</b>	SGD100 – SGD 150
<b>Telecommunications:</b>	SGD30 – SGD50
<b>Course Materials and Stationery:</b>	SGD30 – SGD100
<b>Entertainment and Recreation:</b>	SGD100 – SGD300

Actual expenses will vary depending on the choice of accommodation and spending habits of individual.
