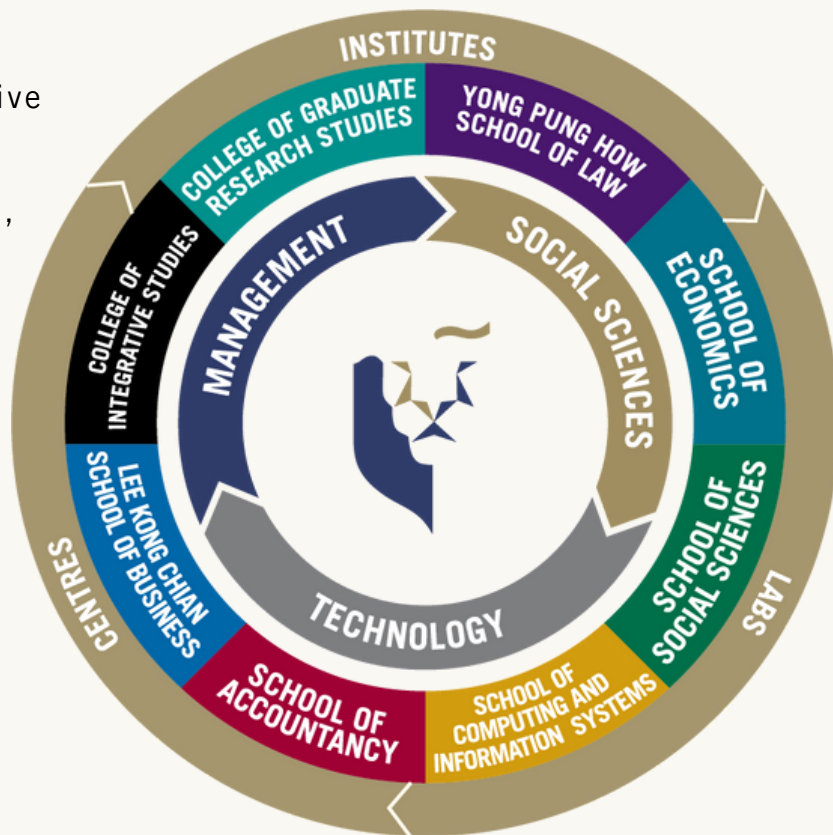


SMU IS GLOBAL

- (If English is not the main language of instruction of your university) Either your IELTS or TOEFL test results. We admit students who score 6.5 and above for IELTS, or 577 points (paper-based) or 90 points (Internet-based) for TOEFL.
